Re: Tentative Agreement, Scheduled Ratification Meetings and **Expanded Voting Hours**

Greetings all:

I am glad to announce that as of yesterday, November 15, IBEW Local Union 30 reached a Tentative Agreement and signed a Memorandum of Agreement with the Governor's Office of Employee Relations. While we will be sending out a formal letter, this email is being sent to provide you with information concerning the next important step.... Voting on the contract!

The contract ratification process includes conducting several information and voting sessions. We have scheduled three sessions at three separate locations for your convenience. At each of these sessions the following activities will occur:

1. Presentation on the contract provisions.
2. Question and answer sessions with members of the Contract Bargaining Team.
3. Opportunity to review MOA and Salary Guide.
4. Voting on the contract by the membership.

It is very important we have a strong turnout so please make every effort to attend one of the scheduled sessions listed below.

Take Notice: We have heard from some of you that expanded hours will likely help get you there and out to vote. As a result we have expanded the voting hours to 8:00 PM at all voting sites!

Parsippany on 11-28 and Hammonton on 11-30 will be open for voting from 4:00 PM to 8:00 PM. Presentations to explain the contract reopener held hourly beginning at 4:30 PM.

Trenton on 11-29 will be open for voting for extended hours from 11:00 AM to 8:00

PM, because of the number of managers in that proximity. Contract explanation presentations will be held hourly beginning at 11:30 AM.
